Thank you for choosing Thoughtful Kids Consignment for all your resale needs! Before we can help you recirculate your gently used kid's gear, please read our consignment agreement closely, then sign and return to us. All agreements and questions can be sent to info@tkconsign.com.

How it works:

Gather your best pre-loved children's clothing, shoes, and accessories - and bring no more than 50 items (think 3 re-usable shopping bags worth) by using one of our meet-up options below:

- # 1 - Convenient weekly Pop-Ups: **See our calendar for events around WNY – and at our Storefront:

- # 2 - Use our concierge pickup service and let us come to you!

Condition:

Please bring garments in clean, and folded – and please leave out any overly-fragranced or smokey items. These should be your best pieces, and be free of any major wear & tear, including holes, pilling, stains, and missing buttons/snaps.

Sorting through items may take up to 30 minutes, depending on the quantity. During special pop-up events, we may ask that you give us till the end of the event/day to sort through your items for purchase or consignment, or to come back at a pre-determined time. We want to be sure we have the time needed to review your items and get you the best possible return on your investment.

What we look for:

Infant and Children's clothing, sizes Newborn through Toddler 5T, and Kids size XS (4/5) through XL (10/12). That includes dresses, leggings/pants, tops/tees/blouses, onesies, holiday outfits, costumes, outerwear: including jackets, fleeces, bunting, snowpants/suits, and cold weather accessories, bathing suits & summer gear also. Boutique and one-of-a-kind handmade items are always a plus!

1. Accounts:

We will sort through your items and decide what we feel is suitable for our store. Once items are decided on, we will set up an account with the information provided on our Consignor Contact Sheet. Each item will then be tagged with your unique Consignor Number. For each item sold, you will receive 40% of the sales price (35% for pickup clients).



2. Pricing:

Thoughtful Kids reserves the right to set prices on each consigned article. We will base our pricing off comparable pieces, and the items' current condition (Good, Very Good, Brand New, etc). Any markdowns or discounts will be taken at our discretion during any point of the consignment period.

3. Payments

Payments are processed once a month for items sold the preceding month. Amounts less than \$10 will be accrued unless an explicit check is requested. Payments are ready by the 10th of the month, no additional notifications will be sent. Consignor may choose payment via check, venmo, or credit towards Thoughtful Kids Consignment inventory. Store credit will be issued at a 50% consignment split, rather than the normal 40%.

4. Consignment Period:

The consignment date ends ONE YEAR from the date the items are accepted (unless otherwise stated), and it is every consignor's responsibility to keep track of this date. If you choose to have your unsold items returned to you, they must be picked up ON or BEFORE the last day of your consignment period. All items that are not claimed by the end of the consignment period will be the property of Thoughtful Kids Consignment and sold or donated at TKC's discretion. A tax slip will be provided from the charity of our choosing, upon request only.

5. Liability

Thoughtful Kids Consignment is not responsible for any lost to theft, vandalism, fire, natural disasters, or any other reason. All risk of ownership of consigned items shall stay with the consignor. Thoughtful Kids Consignment does not make any warranties or representations about the safety or suitability of items consigned. TKC has no experience in manufacturing, repairing, or inspecting merchandise for safety, ease of use, or fitness for a particular purpose and therefore disclaims any responsibility for recalls, defective merchandise, or safe usage for any purpose.

6. Updates & Changes

Thoughtful Kids Consignment reserves the right to alter this policy at any time. It is the consignor's responsibility to check the current agreement on our website for any updates (www.tkconsign.com).

7. Misc.

This consignment agreement is the full written and complete agreement between Thoughtful Kids Consignment and the Consignor. Any amendments, additions, or modifications to this Agreement must be in writing and signed by both parties in a fashion indicating that both parties know they are making a change to these terms.
